**TERMINATION AND RELEASE OF
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of April 27, 2021 (the “Effective Date”), is made by **UBS AG, STAMFORD BRANCH**, a Switzerland corporation, in its capacity as collateral agent (the “Collateral Agent”), in favor of **RSA SECURITY LLC**, a Delaware limited liability company with an address at 174 Middlesex Turnpike, Bedford, Massachusetts 01730 (the “Grantor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

WHEREAS, the Collateral Agent entered into that certain First Lien Trademark Security Agreement dated as of September 1, 2020, with the Grantor, notice of which was recorded by the United States Patent and Trademark Office on September 1, 2020 at Reel 7039, Frame 0027 (the “Trademark Security Agreement”);

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of its right, title or interest in, to or under the Trademark Collateral, including the Trademarks listed in Schedule I.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
