(NUNC PRO TUNC)

Whereas, PARTERRE FLOORING AND SURFACE SYSTEMS LLC, a Delaware limited liability company, ("ASSIGNOR") has adopted, owned and used the trademarks set forth in the attached Schedule A ("REGISTERED MARKS") and has intended to use, and applied under an intent-to-use basis (15 U.S.C. §1051(b)), to register the trademark set forth in Schedule B ("ITU MARK") (the "REGISTERED MARKS" and the "ITU MARK" being collectively referred to as the "MARKS");

Whereas, pursuant to and as set forth in a certain Asset Purchase Agreement between ASSIGNOR and AHF, LLC, a Delaware limited liability company, ("ASSIGNEE") dated January 6, 2021 ("AGREEMENT"), ASSIGNOR assigned the MARKS, and the goodwill associated therewith, to ASSIGNEE; and

Whereas, pursuant to the AGREEMENT, ASSIGNEE acquired the entire business or portion thereof to which the ITU MARK pertains as required by 15 U.S.C. §1060;

Now, therefore, for good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR agrees that ASSIGNOR hereby assigned unto ASSIGNEE *nunc pro tunc* effective as of January 6, 2021, all right, title and interest in and to the MARKS throughout the world, together with all derivations thereof and including all goodwill associated therewith, whether based on common law or the laws of the various states, and the right (but not the obligation) to assert such trademarks and other assigned rights to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur.
