**TRADEMARK RELEASE AND REASSIGNMENT**

THIS SECOND LIEN TRADEMARK RELEASE AND REASSIGNMENT is made as of April 28, 2021, by The Northwestern Mutual Life Insurance Company, as collateral agent (in such capacity, "Collateral Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Tru Tech Systems, LLC, a Delaware limited liability company (the "Grantor"), and Collateral Agent were parties to that certain Second Lien Trademark Security Agreement dated as of September 3, 2019 (the "Security Agreement"), pursuant to which Grantor granted to Collateral Agent a continuing security interest in and lien on the Trademark Collateral (as defined below);

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on September 3, 2019, at Reel 6735, Frame 0423;

WHEREAS, Grantor has requested that Collateral Agent release its security interest in and lien on the Trademark Collateral and reassign any and all rights in the same to Grantor;

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the Collateral Agent's security interest in and lien on the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby releases, discharges, terminates and cancels its liens and security interest in all right, title and interest of the Grantor in, to and under the following:

(i) all of such Grantor's right, title and interest in, to and under its United States Trademark applications and registrations, including, without limitation, those listed on Schedule I attached hereto (the "Trademark Collateral");

(ii) all Proceeds and products of the Trademark Collateral;

(iii) the goodwill of the businesses with which the Trademark Collateral is associated;  
and

(iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademark Collateral or unfair competition regarding the same.

2. Collateral Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent's right, title and interest in and to the Trademark Collateral.
