All capitalized terms used herein and not defined shall have the meanings assigned to them in the Purchase Agreement (as defined below).

Recitals:

WHEREAS, Seller Assignor and Sole Shareholder Assignor have each adopted and used the trademark(s) as set forth in that certain Asset Purchase Agreement (the "Agreement"), dated as of December 31, 2020, by and Seller Assignor, Sole Shareholder Assignor and Assignee (the "Agreement") under the terms and conditions of the Agreement and referenced as Schedule 6(x) of the Agreement and/or Exhibit "C" of this Trademark Assignment (hereinafter referred to as the "Trademarks"); and

WHEREAS, Assignee, desires to acquire all of the right, title, and interest in and to the Trademarks, including the goodwill associated therewith.

NOW THEREFORE, for good and valuable consideration as set forth herein and in the Agreement, the receipt of which consideration is hereby acknowledged by the undersigned:

1. Each Assignor hereby sells, transfers, conveys, and assigns all of such Assignor's right, title, and interest in and to the Trademarks, as well as the goodwill of the business symbolized thereby, the right to register the Trademarks worldwide, and the right to sue for past, present, and future infringement, to the Assignee, and the Assignee hereby accepts such assignment.

2. Each Assignor sells, assigns, transfers and sets over to Assignee, and its lawful successors and assigns, such Assignor's entire right, title, and interest in and to (a) the Trademarks, (b) all goodwill symbolized by and associated with the business conducted under such Trademarks, (c) all registrations and applications (including intent-to-use applications) for the Trademarks together with the business or portion thereof to which the Trademarks apply, which business is ongoing and existing, (d) all income, royalties, damages and payments in respect of the Trademarks, and (e) all rights to sue and recover for any past, present or future infringements, dilution, damage, profits or injury (and including the right to take over and continue any and all existing suits) to the Trademarks.

3. Each Assignor hereby authorizes and requests the U.S. Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Trademarks and all applications and registrations thereof, and to issue all corresponding registrations to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

4. Each Assignor hereby agrees, without further consideration, to execute all papers and to perform such other proper acts as Assignee or its successors or assigns may deem reasonably necessary to secure for Assignee or to its successors or assigns, or to evidence the rights, hereby transferred.

5. This Trademark Assignment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.




