TERMINATION AND REASSIGNMENT OF SECURITY INTEREST
IN TRADEMARKS AND COPYRIGHTS

WHEREAS, MUMBOJUMBO INC., a Delaware corporation, MUMBOJUMBO DISTRIBUTION LLC, a Texas limited liability company, and MUMBOJUMBO LLC, a Texas limited liability company ("**Borrower**" or collectively "**Borrowers**"), and BANK LEUMI USA, a banking corporation organized under the laws of the State of New York ("**Lender**"), are parties to a certain Amendment to Second Forbearance Agreement (the "**Amendment**") dated March 21, 2012. Each capitalized term herein shall have the meaning given to such term in the Amendment and the Loan Documents (as defined below); and

WHEREAS, on March 15, 2010, Borrowers and Lender entered into a promissory note (the "**Note**") (the Note and all documents executed in connection therewith as amended and hereinafter collectively referred to as the "**Loan Documents**"); and

WHEREAS, on July 29, 2011, Borrowers and Lender entered into a Second Forbearance Agreement, (the "**Second Forbearance Agreement**"); and

WHEREAS, Borrower, MumboJumbo LLC is the owner of record of the intellectual property, including the copyrights, trademarks and applications listed on the attached Exhibit A (the "**Intellectual Property**"); and

WHEREAS, Borrowers entered into the Amendment wherein MumboJumbo, LLC, granted a security interest in Intellectual Property listed on the attached Exhibit A; and

WHEREAS, Borrowers have paid the Note in full with interest and have otherwise completed their obligations under the Amendment, Second Forbearance Agreement and Loan Documents; and

WHEREAS, Lender desires to release and terminate its security interest in the Intellectual Property and to terminate the Amendment and its security agreement therein;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby:

1. Releases, terminates and reassigns the secured interest and lien granted by Borrowers and Borrower, MumboJumbo LLC to Lender pursuant to the Amendment, Note and Loan Documents in the copyrights, trademarks and applications more fully described in Exhibit A.
2. Reassigns, transfers, sets over and reconveys to Borrower, MumboJumbo LLC all of Lender's right, title and interest in and to the Intellectual Property described in Exhibit A.

3. Authorizes Borrower, MumboJumbo LLC to file this Termination and Reassignment of Security Interest in Trademarks and Copyrights with the United States Copyright Office and United States Patent and Trademark Office.
