RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of April 30, 2021 (the “Effective Date”), is made by Barclays Bank PLC, in its capacity as Administrative Agent (the “Agent”), in favor of Unity Technologies SF and Mercer Road Corp. (the “Grantors” and individually, a “Grantor”).

WHEREAS, pursuant to that certain Collateral Agreement, dated as of December 20, 2019, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Collateral Agreement”), the Grantors granted to the Agent, in its capacity as Administrative Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Collateral Agreement, the Grantors executed and delivered a Trademark Security Agreement, dated as of December 20, 2019, as supplemented by Supplement No.1, dated March 31, 2021 (the “Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 23, 2019 at Reel/Frame 6824/0061 and Supplement No.1 to the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 1, 2021 at Reel/Frame 7247/0193;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Collateral Agreement or the Trademark Security Agreement, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in all of the Grantors’ right, title and interest in, to and under the Trademarks, including the registrations and applications thereof listed on Schedule I attached hereto, arising under the Collateral Agreement or the Trademark Security Agreement. If and to the extent that the Agent has acquired any right, title or interest in, to or under the Trademark Collateral under the Collateral Agreement or the Trademark Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns all such right, title or interest to each Grantor.

3. Termination. The Agent, without representation or warranty of any kind, hereby terminates and cancels the Trademark Security Agreement.

4. Further Assurances. The Agent hereby authorizes Grantor and its successors, assigns or other legal representatives, to record this Release with the United States Patent and Trademark Office. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
