
NOW, THEREFORE, for consideration of \$100 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

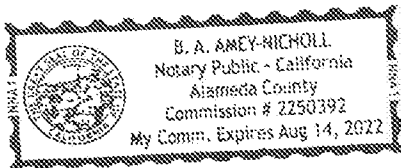


