

INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this "Assignment"), including all schedules attached hereto, is made effective this 22nd day of April, 2021 (the "Effective Date"), by and between Michael J. WHEREAS, Eber wishes to assign to Holdings, and Holdings wishes to acquire from Eber, all right, title, and interest in and all goodwill associated with the Assigned IP.

NOW, THEREFORE, for good and valuable consideration, the receipt, adequacy, and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Parties agree as follows:

- 1. As of the Effective Date, Eber hereby sells, contributes, grants, bargains, conveys, transfers, assigns and delivers to Holdings all right, title and interest in, to and under the Assigned IP, together with the goodwill associated therewith, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations and all corresponding rights that are or may be secured under applicable laws, nor or hereafter arising or in effect, for Holdings' own use and enjoyment, and for the use and enjoyment of Holdings' successors, assigns, and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Eber if this Assignment had not been made, together with all rights to collect royalties, products and proceeds in connection with any of the foregoing and all rights to sue for past, present, or future infringement, misappropriation, unfair competition, dilution, or other violation of the foregoing, and all rights to recover damages or lost profits in connection therewith, and all rights corresponding thereto.
- 2. Eber shall, without further consideration, execute and deliver such additional documents and provide assistance reasonably required or requested by Holdings, its successors and assigns, and their legal representatives (including, without limitation, execution and delivery of any affidavits, declarations, oaths, or other documents as may reasonably be required) to secure and enforce the rights granted to Holdings under this Assignment.

- 3. Holdings may record this Assignment with the United States Patent and Trademark Office, U.S. Copyright Office, and with comparable offices in other jurisdictions throughout the world. All costs associated with any such registrations or recordations shall be paid by Holdings.
- 4. This Assignment shall inure to the benefit of and be binding upon the Parties and their respective successors and permitted assigns.
- 5. This Assignment shall be governed by and construed in accordance with the laws of the State of Illinois, without reference to its conflict of law principles.
- 6. This Assignment may be executed in counterparts, each of which shall be deemed an original, and together shall constitute one and the same agreement and shall be effective as of the Effective Date indicated above when one or more counterparts have been signed by each of the Parties and delivered to the other Party, it being understood that both Parties need not sign the same counterpart. This Assignment may be executed by facsimile or electronically transmitted signatures and such signatures shall be deemed to bind each Party as if they were original signatures.
- 7. This Agreement is being delivered and executed pursuant to the Purchase Agreement and is subject to all the terms and conditions of the Purchase Agreement. No provision of this Agreement will enlarge, alter or amend the terms or provisions of the Purchase Agreement. Notwithstanding anything to the contrary set forth herein, if there is any conflict between the terms and conditions of this Agreement and the terms and conditions of the Purchase Agreement, then the terms and conditions of the Purchase Agreement control.
