**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 14, 2021 by FIRST MIDWEST BANK ("Bank").

**WITNESSETH:**

WHEREAS, Bank and Ambulatory Management Solutions, LLC, an Illinois limited liability company ("Grantor"), were parties to that certain Grant of Trademark Security Interest dated as of July 30, 2018 (the "Security Agreement" capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), and that certain Pledge and Security Agreement, dated as of July 30, 2018, pursuant to which Grantor granted a security interest to Bank in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Bank, including the Trademarks set forth on **Schedule I** hereto; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on August 2, 2018, at Reel 006414, Frame 0574; and

WHEREAS, Grantor has requested that Bank release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Bank hereby releases its continuing first priority security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral");

(a) each Trademark listed on **Schedule 1** annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(b) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Bank hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Bank, all of Bank's right, title and interest in and to the Trademark Collateral.

3. Bank hereby further authorizes and consents that this release may be recorded and indexed by the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office.
