
BILL OF SALE



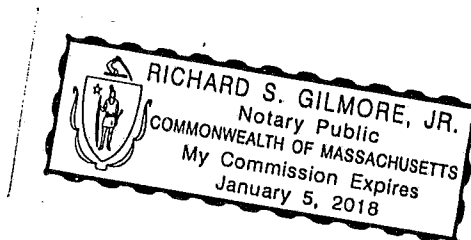

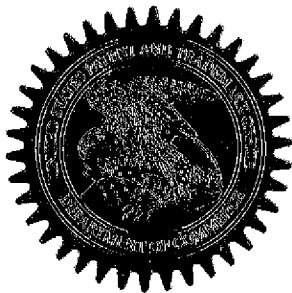
