CONFIRMATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

RECITALS:

- A. The Maple Treat Corporation (the "**Obligor**"), a corporation constituted under the laws of Canada, is the owner of (i) the trademarks set forth in Exhibit "A", the registrations and applications for the trademarks identified therein and the underlying goodwill of said trademarks (collectively the "Trademarks") and (ii) the copyrights set forth in Exhibit "A", the registrations and applications for the copyrights identified therein and the goodwill of said copyrights (the "**Copyrights**" and, together with the Trademarks, the "**Intellectual Property**").
- B. The Obligor has entered into a deed of hypothec dated April 29, 2021 with Computershare Trust Company of Canada, in its capacity as collateral agent to holders of 3.49% Senior Guaranteed Notes of the Obligor (in such capacity, the "**Collateral Agent**") at 1500 Robert-Bourassa Boulevard, 7th Floor, Montreal, Quebec, H3A 3S8 (as amended, modified, supplemented or restated from time to time, the "**Deed of Hypothec**") under which the Obligor hypothecated to and in favour of the Collateral Agent certain property, including the Intellectual Property, as security, inter alia, for its obligations under a certain note purchase agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged and in accordance with the terms and obligations set forth in the Deed of Hypothec, the Obligor confirms the grant to the Collateral Agent under the Deed of Hypothec of a security interest in and to the Intellectual Property.
