AGREEMENT

Assignment of trademark application

"Hensel" LLC, a company incorporated and acting under the laws of the Russian Federation, represented by General Director Mr. Bitiashvili Georgy, acting on the basis of the Charter, hereinafter referred to as the "Assignee".

The Assignor is owner of the following trademark application:

The Assignor hereby assigns and transfers Application and all rights, title and interest involved as well as the associated goodwill, including that portion of Assignor's business to which the mark pertains, to the Assignee. This Assignment is made in respect of all goods for which Application was filed.

For the assignment of the Application Assignee pays to the Assignor a remuneration in the amount of USD 920 (Nine hundred twenty) by bank transfer of funds to the Assignor's account within 10 (ten) working days from the date of signing of Agreement by the Parties.

Parties shall pay all respective taxes as applicable to payments between the Parties under this Agreement.

Parties agreed that Assignee shall pay all fees (US lawyers fees) necessary for recording Assignee as a new owner of the trademark Application. Assignor hereby confirms the sufficiency of the agreed consideration.

The Assignor undertakes to give its full cooperation for all formalities in order to record the Assignee as the new owner of the trademark Application.

This Agreement shall be governed and interpreted in accordance with the laws of Russia. Any disputes or disagreements of the Parties in connection with this Agreement, if they are not resolved through negotiations, shall be settled under exclusive jurisdiction of Russian courts.

Agreement is drawn up in two languages in 2 copies. In the event of a discrepancy in interpretation, priority should be given to the Russian version.

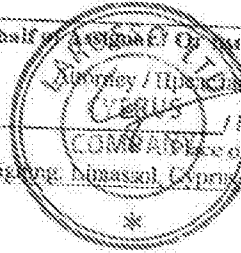
