**TERMINATION OF FIRST LIEN SECURITY INTEREST IN UNITED STATES  
TRADEMARKS**

This **TERMINATION OF FIRST LIEN SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this "Termination"), dated as of May 4, 2021, is made by Jefferies Finance LLC in its capacity as collateral agent (the "Collateral Agent") in favor of Brakes Plus, LLC, a Delaware limited liability company ("Brakes Plus"), Express Oil Change, L.L.C., a Delaware limited liability company ("EOC"), Mavis Southeast LLC, a Delaware limited liability company ("Mavis Southeast"), Mavis Tire Supply LLC, a Delaware limited liability company ("Mavis Tire Supply"), Somerset Tire Service, Inc., a New Jersey corporation ("STS"), and Town Fair Tire Centers, Inc., a Delaware corporation ("Town Fair Tire Centers"), and, together with Brakes Plus, EOC, Mavis Southeast, Mavis Tire Supply, Mavis Connecticut and STS, collectively, the "Pledgors"). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Security Agreement (as defined below).

**WHEREAS**, pursuant to that certain (i) First Lien Pledge and Security Agreement, dated as of March 20, 2018 (as it may be amended, restated, supplemented, waived or otherwise modified from time to time, the "Security Agreement") between the Pledgors, the other pledgors party thereto and the Collateral Agent, (ii) First Lien Trademark Security Agreement, dated as of March 20, 2018, executed by Brakes Plus in favor of the Collateral Agent, (iii) First Lien Trademark Security Agreement, dated as of March 20, 2018, executed by EOC in favor of the Collateral Agent, (iv) First Lien Trademark Security Agreement, dated as of March 20, 2018, executed by Mavis Southeast in favor of the Collateral Agent, (v) First Lien Trademark Security Agreement, dated as of March 20, 2018, executed by Mavis Tire Supply in favor of the Collateral Agent, (vi) First Lien Trademark Security Agreement, dated as of March 20, 2018, executed by STS in favor of the Collateral Agent, and (vii) First Lien Trademark Security Agreement, dated as of November 30, 2020, executed by Town Fair Tire Centers and Mavis Tire Supply in favor of the Collateral Agent, (clauses (ii) through (vii), collectively, the "Trademark Security Agreements"), the Pledgors pledged and granted to the Collateral Agent a security interest in and continuing lien on all of the Pledgors' right, title and interest in, to and under the Trademark Collateral;

**WHEREAS**, the security interest in the Trademark Collateral pledged and granted by the Pledgors to the Collateral Agent under the Trademark Security Agreements were recorded at the United States Patent and Trademark Office (i) with respect to Brakes Plus, on March 20, 2018, at Reel 6296, and Frame 0236, (ii) with respect to EOC, on March 20, 2018, at Reel 6296, and Frame 0207, (iii) with respect to Mavis Southeast, on March 20, 2018, at Reel 6296, and Frame 0047, (iv) with respect to Mavis Tire Supply, on March 20, 2018, at Reel 6296, and Frame 0118, (v) with respect to STS, on March 20, 2018, at Reel 6296, and Frame 0244, and (vi) with respect to Town Fair Tire Centers and Mavis Tire Supply, on December 1, 2020, at Reel 7119, and Frame 0857; and

**WHEREAS**, the Collateral Agent has agreed to terminate, release and discharge its security interest and lien on all Trademarks owned by Pledgors, including, without limitation, the Trademark Collateral (as defined in each of the Trademark Security Agreements) and the trademark registrations and applications listed on **Schedule 1** hereto (the "Trademark Collateral").

**NOW, THEREFORE**, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of the Pledgors secured by the Trademark Collateral pursuant to the Security Agreement and the Trademark Security Agreements, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent hereby terminates, releases and discharges any and all of its mortgages, liens, and security interests in and to all of the Trademark Collateral and hereby

reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in the Trademark Collateral to each Pledgor, as applicable, including, without limitation, any and all causes of action which may exist by reason of infringement of the Trademark Collateral.

2. The Collateral Agent hereby terminates, cancels, fully and finally releases, and discharges any other rights with respect to the Trademark Collateral that it may have under the Security Agreement.

3. The Collateral Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office record this Termination.

4. The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at the Pledgors' sole cost and expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.

5. THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.



