TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “**Termination and Release**”), is dated as of April 30, 2021, and made by CIBC BANK USA (the “**Grantee**”), to ARRIVE MOBILITY INC., a Delaware corporation (formerly known as ParkWhiz, Inc., the “**Grantor**”).

WHEREAS, pursuant to that certain (i) Loan and Security Agreement dated as of January 29, 2016 (as amended, restated or otherwise modified through the date hereof, the “**Loan Agreement**”) between Grantor and Grantee; (ii) Trademark Security Agreement dated as of April 5, 2018 (the “**Trademark Security Agreement**”) made by Grantor in favor of Grantee, and (iii) Trademark Security Agreement Supplement No. 1 dated as of April 9, 2020 (the “**Trademark Security Agreement Supplement**”) made by Grantor in favor of Grantee, a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on April 6, 2018 at Reel 6308, Frame 0826;

WHEREAS, the Trademark Security Agreement Supplement was recorded with the trademark division of the United States Patent and Trademark Office on April 10, 2020 at Reel 6913, Frame 0367; and

WHEREAS, Grantee now desires to terminate and release the Loan Agreement, the Trademark Security Agreement and the Trademark Security Agreement Supplement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Grantee hereby states as follows:


1. **Definitions.** The terms “Trademarks” as used herein, shall mean all of the Grantor’s right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto.

2. **Release of Security Interest.** Grantee does hereby terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Loan Agreement, the Trademark Security Agreement and the Trademark Security Agreement Supplement, in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.


