RELEASE OF SECURITY INTEREST

This Release of Security Interest ("Release") is made as of January __, 2019, by WESTERN ALLIANCE BANK, an Arizona corporation ("Bank") in favor of ROCKET LAWYER INCORPORATED, a Delaware corporation, ("Grantor") with its principal place of business located at 101 Second Street, 4th Floor, San Francisco, CA 94105.

Recital

WHEREAS Grantor granted to Bank a security interest in the trademarks and patents described on Exhibits B – C, respectively, attached hereto (collectively, the "Intellectual Property") under an Intellectual Property Security Agreement dated as of December 23, 2014, by and between Grantor and Bank, as amended from time to time (the "Security Agreement") and recorded with the US Patent and Trademark Office as set forth on Exhibits B – C.

WHEREAS Grantor has no outstanding obligations to Bank under the terms of the Security Agreement and Bank agrees to release its security interest in the various intellectual property set forth in the Security Agreement, including without limitation the trademarks and patents described on Exhibits B – C attached hereto (all such items, collectively, the "Intellectual Property Collateral").

Agreement

Now therefore, Bank hereby terminates the Security Agreement and terminates, releases and discharges any and all security interest that it has pursuant to the Security Agreement in all collateral, including the Intellectual Property Collateral described on Exhibits B – C. Bank hereby reassigns to Grantor, without warranty or recourse, all interest of Bank in such collateral, including the Intellectual Property Collateral described on Exhibits B – C.

Bank agrees to take all further actions, and provide to Grantor and its successors, assigns and legal representatives, at Grantor's expense, all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

The parties agree this Release shall be governed by, and construed in accordance with, the internal laws of the State of California, without regard to principles of conflicts of law. Each of Grantor and Bank hereby submits to the exclusive jurisdiction of the state and Federal courts located in the County of Santa Clara, State of California.
