RELEASE OF TRADEMARK SECURITY INTEREST

April 3, 2018


For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, GOLUB CAPITAL LLC, in its capacity as agent (the "Agent"), pursuant to that certain Loan and Security Agreement dated as of August 23, 2016, by and among the Loan Parties from time to time party thereto and the Agent for the benefit of the Secured Parties referenced therein (as the same may have been amended, modified, restated, or supplemented from time to time, the "Loan Agreement"), does hereby unconditionally and expressly release, terminate and forever discharge and extinguish any and all of its right, title and interest in and to any and all liens and security interests it may have under the Trademark Collateral identified in the Trademark Security Agreement dated as of August 23, 2016, between the Agent and XMATTERS, INC., a California corporation (the "Grantor") (the "Trademark Security Agreement"), including, without limitation, the trademarks listed on Schedule 1 attached hereto (collectively, the "Released Collateral"), arising from the Loan Agreement and the Trademark Security Agreement, which was recorded in the United States Patent and Trademark Office ("PTO") on August 24, 2016 against the United States trademarks listed on Schedule 1 at Reel/Frame Numbers 5864/0189. The Agent hereby (i) releases, retransfers and reassigns to the Grantor the security interest and all of the Agent's right, title and interest in, to and under the Released Collateral and (ii) terminates the Trademark Security Agreement. The Agent will take all such further actions, execute and deliver, at the request and cost of the Grantor, such further instruments, documents and release forms as the Grantor may reasonably request or are required to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.

Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Loan Agreement and the Trademark Security Agreement, as applicable. This Release of Trademark Security Interest shall be binding upon the Agent, its legal representatives, assigns and successors. The Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release of Trademark Security Interest.
