Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned limited liability company executed the following certificate of merger.

**FIRST:** The name and jurisdiction of formation or organization and domicile of each of the constituent entities is: Validus Pharmaceuticals LLC, a Delaware limited liability company ("Validus"), US Pharmaceuticals Holdings I LLC, a Delaware limited liability company ("USPHI"), and U.S. Pharmaceuticals Holdings II LLC, a Delaware limited liability company ("USPHII").

**SECOND:** Validus, USPHI and USPHII have entered into an Agreement and Plan of Merger, dated as of December 18, 2020 (the "Merger Agreement"), providing for the merger of USPHI and USPHII with and into Validus pursuant to Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "DLLCA"). The Merger Agreement has been approved, adopted, certified, and executed by Validus, USPHI and USPHII in accordance with Sections 18-204 and 18-209 of the DLLCA.

**THIRD:** The name of the surviving limited liability company is Validus Pharmaceuticals LLC, and the names of the limited liability companies being merged into this surviving limited liability company are US Pharmaceuticals Holdings I LLC and U.S. Pharmaceuticals Holdings II LLC.

**FOURTH:** The merger is to become effective at 11:59 p.m. on December 31, 2020.


