WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of February 12, 2002 (the "IP Security Agreement"), recorded in the United States Patent and Trademark Office at Reel/Frame 2521/0932, Innergy Power Corporation ("Releasee") granted to Silicon Valley Bank ("Releasor"), a security interest in all right, title and interest of Releasee in and to certain intellectual property described therein; and

WHEREAS, the IP Security Agreement inadvertently included a typographical error in the application number for the Innergy Power trademark application and due to the typographical error, the IP Security Agreement was improperly recorded against FRESH CHURNED, Serial No. 87/104,667, US Registration Number 5388609 ("FRESH CHURNED Mark").
