**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 30, 2021, by VARAGON CAPITAL PARTNERS AGENT, LLC, as administrative agent (“Agent”) for the Secured Parties. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Global Convergence, Inc., a Florida corporation (the “Grantor”), and Agent are parties to that certain Trademark Security Agreement dated as of February 24, 2021 (the “Security Agreement”), pursuant to which Grantor granted a security interest to Agent in certain IP Collateral as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule A hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on February 25, 2021, at Reel 7203 Frame 0524;

WHEREAS, Grantor has requested that Agent release its security interest in the IP Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the IP Collateral, including but not limited to the following:

the registered Trademarks (as defined in the Security Agreement) and Trademarks for which applications are pending in the United States Patent and Trademark Office set forth in Schedule A hereto.

2. Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title and interest in and to the IP Collateral.
