**TRADEMARK SECURITY AGREEMENT/FINANCING STATEMENT
NOTICE OF TERMINATION AND RELEASE**

This NOTICE OF TERMINATION AND RELEASE (“Notice of Termination and Release”) is dated May 4, 2021 and made by Spartech LLC, a Delaware limited liability company, and successor-in-interest to Atlas Plastics Corporation (“Grantor”).

WITNESSETH

WHEREAS, on August 7, 1987, Grantor and Chemical Bank (“Secured Party”) entered into a Security Agreement (the “Agreement”), relating to certain U.S. trademark registrations owned at the time by the Secured Party;

WHEREAS, the Agreement was recorded with the United States Patent and Trademark Office on July 30, 2000, at Reel 0571/Frame 0287;

WHEREAS, it is Grantor’s understanding that the Grantor’s obligations and liabilities have been paid in full, and the Secured Party agreed to terminate and release all security interests in the Grantor’s Trademarks (as defined below), Licenses (as defined below), and goodwill;

NOW, THEREFORE, Grantor hereby provides notice that because to the best of Grantor’s knowledge, the security interests in the Trademarks (as defined below), including the trademark registrations listed on the attached Schedule A, have been terminated and released as follows:

Release of Security Interests. Grantor hereby provides notice that the Secured Party has terminated and released, and hereby terminates and releases, all security interests in all of Grantor’s:

(a) registered trademarks and trademark applications, including, without limitation, the registered trademarks and applications listed on Schedule A, attached hereto and made a part hereof, and (i) renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, (iii) the right to sue for past, present, and future infringements thereof, and (iv) all of Grantor’s rights corresponding thereto throughout the world (all of the foregoing registered trademarks and applications, together with the items described in clauses (i)-(iv), are sometimes hereinafter individually and/or collectively referred to as the “Trademarks”);

(b) trademark license agreements with any other party, whether Grantor is a licensee or licensor under any such license agreement (all the foregoing are hereinafter referred to collectively as “Licenses”); and

(c) the goodwill of Grantor's business connected with and symbolized by the Trademarks.
