## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”), dated as of October 25, 2018, is made by ALLY COMMERCIAL FINANCE LLC (“**Administrative Agent**”).

**WHEREAS**, pursuant to that certain Ratification and Amendment of Grant of Security Interest in Trademarks, dated February 24, 2017 (the “**Trademark Agreement**”), TRAFFICWARE, LLC, a Texas limited liability company (“**Grantor**”) granted to Administrative Agent, on behalf of itself and the Lenders (as defined in the Trademark Agreement) a security interest in certain trademarks of Grantor, which trademarks are more fully identified on Schedule A annexed hereto and made a part hereof (“**Registered Trademarks**”).

**WHEREAS**, Administrative Agent’s security interest was recorded with the United States Patent and Trademark Office (“**USPTO**”) by Grantor’s filing of the Trademark Agreement which was recorded with the USPTO on February 28, 2017, at Reel 5997, Frame 0315.

**NOW THEREFORE**, Administrative Agent hereby absolutely, unconditionally, and irrevocably releases, terminates and discharges the Trademark Agreement and Administrative Agent’s security interest in, lien on, and conditional assignment of the Registered Trademarks and Administrative Agent hereby reassigns to Grantor any and all such right, title and interest (if any) that the Administrative Agent may have in the Registered Trademarks. Administrative Agent hereby authorizes the recordation of this Release with the USPTO. Administrative Agent agrees to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Administrative Agent’s security interest in the Registered Trademarks and the termination of the Trademark Agreement. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflicts of law principles (but including and giving effect to Sections 5-1401 and 5-1402 of the New York General Obligations Law).
