**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of May 6, 2021, by **DEUTSCHE BANK TRUST COMPANY AMERICAS**, a New York banking corporation (“Administrative Agent”) in favor of **APTTUS CORPORATION**, a Delaware corporation with an address at 13699 Via Varra, Broomfield, CO 80020, and **APTTEX CORPORATION**, a Delaware corporation with an address at 13699 Via Varra, Broomfield, CO 80020 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain trademark security agreement dated October 2, 2018 (the “Trademark Security Agreement”) with the Administrative Agent, notice of which was recorded on October 2, 2018 at the United States Patent and Trademark Office at Reel 6448, Frame 0043.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.


WHEREAS, each Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of each such Grantor’s right, title and interest in, to and under the Trademarks, whether owned or existing as of the date of the Trademark Security Agreement or at any time thereafter acquired or arising and wherever located, including the Trademarks listed in **Schedule A** (collectively, the “Trademark Collateral”).

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of each of the Grantors, including all of the goodwill associated with or symbolized by the Trademark Collateral, terminates the Trademark Security Agreement, and assigns, transfers and conveys to Grantors any interest in such intellectual property, including the Security Interest. The Administrative Agent further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantors and their successors and assigns in association with the Security Interest, and hereby releases the Grantors and their successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest. The Administrative Agent authorizes and requests the Commissioner for Trademarks and any other government officials to record and register this Agreement.
