**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 26, 2021 (“Release”), is made by JPMorgan Chase Bank, N.A., as Administrative Agent (the “Administrative Agent”) in favor of China Mist Brands, Inc., a Delaware corporation (the “Grantor”).

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated as of March 2, 2015, by and among the Existing Grantors, the Administrative Agent, and others party thereto (the “Security Agreement”), the Existing Grantors granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in any and all right, title and interest of such Existing Grantor in and to trademarks;

WHEREAS, Grantor joined the Security Agreement pursuant to joinder agreements dated as of October 11, 2016;

WHEREAS, pursuant to such joinder agreements and the Trademark Security Agreement, dated as of October 11, 2016, by and between Grantor and the Administrative Agent, Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in any and all right, title and interest of such Grantor in and to all Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on December 1, 2016 at Reel 5933 Frame 0173.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable.

SECTION 2. Termination and Release. The Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

- (a) terminates the Trademark Security Agreement and terminates, cancels, discharges, and releases the continuing security interest in, and any and all right, title and interest of Grantor in and to, all of the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;
- (b) reassigns, grants and conveys to Grantor any and all of the Administrative Agent’s right, title and interest in and to the Trademark Collateral; and
- (c) authorizes the recordation of this Release with the USPTO at the Grantor’s expense.


SECTION 3. Further Actions. The Administrative Agent agrees to take all further actions, and provide to Grantor and its respective successors, assigns or other legal representatives, all such cooperation

and assistance reasonably requested by Grantor, at Grantor's sole cost and expense, to more fully and effectively effectuate the purpose of this Release.

SECTION 4. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regarding to conflicts of law or choice of law principles.
