
Each of the Seller and the Buyer is hereinafter referred to as a “**Party**” and jointly as the “**Parties**.”

WHEREAS, the Parties then entered into an Amendment to the IP Transfer Agreement dated March 26, 2021 to confirm the transfer of rights in the trademark that is the subject of U.S. Registration No. 6188174 (“**Trademark**”) as of October 10, 2019;

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller hereby confirms having sold, conveyed, assigned, and transferred to Buyer all of Seller’s right, title, and interest in and to the Trademark and its registration, including the goodwill of the business symbolized by the Trademark, nunc pro tunc, effective as of October 10, 2019.
