Assignor agrees to perform all affirmative acts that may be necessary or desirable to perfect the assignment described herein at Assignee's sole cost and expense, as well as to cooperate with Assignee in obtaining and/or providing information required in any proceedings relating to the Trademarks, at Assignee's sole cost and expense.

4. Binding Effect. This Assignment shall be binding upon and inure to the benefit of the respective successors and assigns to each of the parties.


