INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this “Assignment”) is made effective and delivered as of May 4, 2021, by and between Koch Agronomic Services, LLC, a Delaware limited liability company (“Assignee”), Compass Minerals USA Inc., Delaware corporation (“Compass Minerals USA”), and Compass Minerals Manitoba Inc., a Manitoba corporation (together with Compass Minerals USA, “Assignor”). Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Purchase Agreement (as defined below).

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement, dated as of April 7, 2021, as amended on the date hereof (the “Purchase Agreement”), pursuant to which, among other things, Assignor has agreed to execute this Assignment wherein Assignor will sell, assign, transfer and convey to Assignee all right, title, and interest of Assignor in, to, and under the Seller Intellectual Property, including the Seller Intellectual Property identified in Schedule A hereto (collectively, the “Acquired Intellectual Property”).

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Assignment. For good and valuable consideration set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably sells, assigns, transfers and conveys to Assignee all of Assignor’s right, title, and interest in, to, and under the Acquired Intellectual Property to the full extent of its ownership and interest therein including any and all goodwill associated therewith.

2. Recordation. Assignor hereby authorizes the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee. Following the date hereof, upon Assignee’s reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Acquired Intellectual Property to Assignee or any assignee or successor thereto.

3. Actions.

(a) Subject to the limitations set forth in Section 3(c) below, Assignor hereby covenants and agrees to and with Assignee and its successors, legal representatives and assigns, that Assignor will sign all papers and documents, take all lawful oaths and do all acts reasonably necessary or required to be done for the procurement, maintenance, enforcement and defense of any Acquired Intellectual Property, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns, shall advise: that any proceeding in connection with said Acquired Intellectual Property is lawful and desirable; or, that any division, continuation or continuation-in-part of any application for Patents, or any reissue, reexamination or extension of any Patents, to be obtained thereon, is lawful and desirable.

(b) Assignor hereby requests the Commissioner for Patents and Trademarks of the United States and any other foreign patent or trademark agency to issue said Acquired Intellectual Property set forth in Schedule A to Assignee, as the assignee of said Acquired Intellectual Property to be issued thereon, for the sole use and benefit of Assignee and its successors, legal representatives and assigns.

(c) Assignor hereby constitutes and appoints Assignee as Assignor's true and lawful attorney in fact, with full power of substitution in Assignor's name and stead, but for Assignee's benefit, to take any and all steps, including proceedings at law, in equity or otherwise, to execute, acknowledge and deliver any and all instruments and assurances necessary or expedient in order to vest the aforesaid Acquired Intellectual Property and causes of action more effectively in Assignee or to protect the same, or to enforce any claim or right of any kind with respect thereto. Assignor hereby declares that the foregoing power is coupled with an interest and is irrevocable.

4. Governing Agreement. This Agreement is expressly made subject to the terms and provisions of the Purchase Agreement. The delivery of this Agreement shall not affect, enlarge, diminish, or otherwise impair any of the representations, warranties, covenants, conditions, indemnities, terms, or provisions of the Purchase Agreement, and all of the representations, warranties, covenants, conditions, indemnities, terms, and provisions contained in the Purchase Agreement shall survive the delivery of this Agreement to the extent, and in the manner, set forth in the Purchase Agreement. In the event of a conflict between the terms and provisions of this Agreement and the terms and provisions of the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern and control.

5. Successors and Assigns. The provisions of this Agreement shall bind and inure to the benefit of Assignee and Assignor and their respective successors and assigns.

6. Governing Law. This Agreement and the legal relations between Assignor and Assignee hereunder shall be governed and construed in accordance with the laws of the State of Delaware, excluding any conflicts of law rule or principle that might refer construction of such provisions to the laws of another jurisdiction.

7. Construction. This Agreement has been negotiated and prepared jointly by all parties hereto, has been reviewed by legal counsel to each party, and, as such, shall not be construed against or in favor of any party by reason of the drafting of any provision by any party or by legal counsel thereto.

8. Captions. The captions and section numbers in this Agreement are for convenience only and shall not be considered a part of or affect the construction or interpretation of any provision of this Agreement.


9. Counterparts. This Agreement may be executed in one or more originals (including by facsimile transmission, scanned pdf, or other electronic means), but all of which together shall constitute one and the same instrument.
