TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of May 7, 2021, by ABACUS FINANCE GROUP, LLC, as administrative agent for itself and the other lending institutions party to the Credit Agreement referred to in the Trademark Security Agreement referred to below (in such capacities, the "Administrative Agent").

WITNESSETH:

WHEREAS, reference is made to that certain Trademark Security Agreement, dated as of January 24, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), by VITAC Corporation, a Pennsylvania corporation (the "Grantor"), in favor of the Administrative Agent;

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted a security interest to the Administrative Agent in the Trademark Collateral identified therein;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 13, 2017, at Reel/Frame 6008/0308; and

WHEREAS, the Administrative Agent now desires to terminate and release its security interest in the Trademark Collateral, including the Trademarks listed on Schedule I hereto (the "Released Trademarks").


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Trademark Security Agreement.
2. Release of Security Interest in Trademark Collateral. The Administrative Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all security interest in the Released Trademarks and the other Trademark Collateral, and any right, title or interest of the Administrative Agent in such Released Trademarks and other Trademark Collateral hereby cease.
3. Recordation. The Administrative Agent authorizes the Grantor and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Grantor's sole expense.
