RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated May 7, 2021 by BMO HARRIS BANK N.A., a national banking association (“*BMO*”), with its mailing address at 111 West Monroe Street, Chicago, IL 60603 acting as collateral agent hereunder for the Secured Creditors as defined in the Agreement referred to below (BMO acting as such administrative agent being hereinafter referred to as “*Agent*”);

WITNESSETH:

WHEREAS, NatureSweet Ltd, now known as NS Brands, Ltd., a Texas limited partnership (“*Debtor*”), with its mailing address at 2338 N. Loop, 1604 West Suite 200, San Antonio, Texas 78248, and Agent were parties to a certain Assignment of Security Interest In Trademarks dated May 29, 2015 between Debtor and Agent which was recorded in the United States Patent and Trademark Office on August 13, 2015 at Reel 5599, Frame 0075 (the “*Agreement*”), pursuant to which Debtor granted to Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “*Trademark Property*”); and

(i) Each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application and all extensions and renewals thereof; and

(ii) All proceeds of the foregoing, including without limitation (x) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing and (y) any and all claims and causes of action by Debtor against third parties for damages, restitution and injunctive and other legal and equitable relief by reason of past, present or future infringement, dilution, misappropriation, violation, misuse, breach or default of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right but no obligation to sue for and collect, or otherwise recover, said damages.
