**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 29, 2021 (“Release”), is made by FIDUS MEZZANINE CAPITAL, L.P., a Delaware limited partnership, as Collateral Agent (“Secured Party”) in favor of INTERSTATE FLOORING, L.L.C., a Missouri limited liability company (“Debtor”).

WHEREAS, pursuant to that certain Trademark Agreement dated April 1, 2016, by and between Secured Party and Debtor (the “Trademark Security Agreement”), which was recorded at the United States Patent and Trademark Office (“USPTO”) on April 4, 2016 at Reel 5764 and Frame 0287 (“Notice”), Debtor granted to Secured Party a security interest in any and all of Debtor’s right, title, and interest in and to certain Trademark Collateral, including the Trademarks listed on Schedule A attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

SECTION 2. Termination and Release. Secured Party, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of its right, title and interest in and to the Trademarks and the use thereof, together with all Trademark Licenses, income, royalties, damages and other payments, proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, granted pursuant to the Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Debtor’s expense.
