## **RELEASE OF TRADEMARK SECURITY INTEREST**

This Release of Trademark Security Interest (this “Release”) is made effective as of May 10, 2021 by Wilmington Savings Fund Society, FSB, a federal savings bank, as successor administrative agent (the “Administrative Agent”) for the Secured Parties, to ADVANCED VISION RESEARCH, INC., a Delaware corporation (the “Grantor”), as follows:

WHEREAS, on April 17, 2014, Grantor, certain of the other Loan Parties and the Administrative Agent entered into an ABL Pledge and Security Agreement (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), and on February 6, 2019, the Grantor and JPMorgan Chase Bank, N.A. (the “Assignor”) entered into a Confirmatory Grant of Security Interest in United States Trademarks (the “Confirmatory Grant”);

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Assignor, on behalf of the Secured Parties, among other collateral, a continuing security interest in all of the Grantor’s right, title and interest in, to and under its trademarks, including goodwill, including but not limited to the trademarks listed on the attached Schedule A;

WHEREAS, the Confirmatory Grant was recorded in the United States Patent and Trademark Office (the “USPTO”) on April 17, 2014, at reel/frame 5264/0087;

WHEREAS, pursuant to the Assignment and Assumption of Confirmatory Grant of Security Interest in United States Trademarks effective as of April 1, 2020 (the “Assignment and Assumption Agreement”), Assignor irrevocably assigned to Administrative Agent all of its rights, powers, privileges, responsibilities, duties and obligations under the Security Agreement, including the Confirmatory Grant;

WHEREAS, the Assignment and Assumption Agreement was recorded in the United States Patent and Trademark Office (the “USPTO”) on April 1, 2020, at reel/frame 6905/0369; and

WHEREAS, the Administrative Agent wishes to release its security interest in the trademarks listed on Schedule A and retransfer and reassign to the Grantor any of the Administrative Agent’s right, title and interest in and to the trademarks listed on Schedule A.

NOW, THEREFORE, the Administrative Agent hereby releases, terminates and discharges any security interest it may have under the Security Agreement, Confirmatory Grant or Assignment and Assumption Agreement in the trademarks listed on Schedule A, and reassigns any and all right, title and interest it may have in and to the trademarks listed on Schedule A to the Grantor, and such security interest shall hereby terminate, cease and become void; and the Administrative Agent hereby consents to the recording of this Release with the USPTO.
