RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, the Assignment and Assumption Agreement was recorded in the United States Patent and Trademark Office (the "<u>USPTO</u>") on April 1, 2020, at reel/frame 6905/0369; and

WHEREAS, the Administrative Agent wishes to release its security interest in the trademarks listed on <u>Schedule A</u> and retransfer and reassign to the Grantor any of the Administrative Agent's right, title and interest in and to the trademarks listed on <u>Schedule A</u>.
