DECLARATION AND CONFIRMATORY ASSIGNMENT

DATE: 30 APRIL 2021

PARTIES:

- (1) SUNDERLAND OF SCOTLAND LIMITED, of Ettrick Riverside, Dunsdale Road, Selkirk, Scottish Borders, TD7 REB, United Kingdom ('Assignor').
- (2) GLENMUIR LIMITED, of Dove Mill, Dove Road off Deane Church Lane, Bolton, BL3 4ET, United Kingdom ('Assignee').

WHEREAS

- (A) The parties agreed that the trade marks listed in Schedule 1 below ('Trade Marks') would be assigned from the Assignor to the Assignee.
- (B) The parties executed an Assignment of Trade Marks in Escrow ('Assignment') on 10 January 2019 to assign the Trade Marks from the Assignor to the Assignee, the Assignment being delivered in escrow to become effective and released from escrow only when certain conditions were satisfied.
- (C) The said conditions have now been satisfied and, accordingly, the Trade Marks have been assigned from the Assignor to the Assignee, including the goodwill and other rights attaching to the Trade Marks.
- (D) The parties now wish to record the assignment.

NOW IT IS CONFIRMED AND DECLARED as follows:

1. The Assignor confirms and declares the assignment to the Assignee, for good and valuable consideration, of all its right, title and interest in and to the Trade Marks and the full and exclusive benefit thereof, including:
 - (a) the goodwill and other rights attaching to the Trade Marks; and
 - (b) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any

infringement, or any other cause of action (including passing off) arising from ownership, of any of the Trade Marks whether occurring before, on or after the date of the Assignment.

2. The Assignee confirms and declares its acceptance of the assignment.
3. To the extent that any rights in and to the Trade Marks were not validly assigned by the Assignment, the Assignor hereby assigns any such rights to the Assignee.
4. The parties confirm that the effective date of assignment of the Trade Marks is 30 April 2021.


