AMENDED AND RESTATED CERTIFICATE OF INCORPORATION

Pocket Outdoor Media, Inc. (the “*Corporation*”), a corporation existing under and by virtue of the General Corporation Law of the State of Delaware (the “*DGCL*”), does hereby certify:

1. The name of the Corporation is Pocket Outdoor Media, Inc.
2. The Corporation was originally incorporated pursuant to DGCL on August 26, 2019.
3. Pursuant to Sections 141(f), 228 and 242 of the DGCL, this Certificate of Amendment (“*Certificate of Amendment*”) amends the Corporation’s Amended and Restated Certificate of Incorporation (the “*Charter*”) by amending and restating Article FIRST of the Charter in its entirety with the following:

“The name of the corporation is Outside Interactive, Inc. (the “*Corporation*”)”

4. All other provisions of the Charter shall remain in full force and effect.
5. This Certificate of Amendment was duly adopted by the board of directors of the Corporation in accordance with Sections 141(f) and 242 of the DGCL and the stockholders of the Corporation in accordance with Sections 228 and 242 of the DGCL.
