**THIS DEED OF ASSIGNMENT is made on**

**BETWEEN**

- (1) **VERTICAL NETWORKS LIMITED**, a company incorporated in England and Wales (company number 09783972), whose registered office address is 34 Park Street, London W1K 2JD (the "Assignor");
- (2) **EM FAMILY TRUST LLC**, a Delaware limited liability company, whose registered office address is Corporate Trust Centre, 1209 Orange Street, Wilmington New Castle County, Delaware 19801 (the "Assignee").

**RECITALS**

- (A) The Assignor is a joint venture company owned by Redwood Investment Asset Holdings LLC and the Assignee.
- (B) The Assignor is the current proprietor of the trade marks set out in the Schedule and the unregistered rights in those trade marks (together the "Trade Marks").
- (C) The Parties have now agreed to enter into this Deed to assign the Trade Marks and the associated goodwill to the Assignee on the terms set out in this Deed.

**IT IS AGREED AS FOLLOWS:**

**1. ASSIGNMENT**

The Assignor hereby assigns to the Assignee all legal and beneficial rights and title which it has in and to the Trade Marks, including, such goodwill as it may have acquired to date in the Trade Marks, all rights to claim priority or seniority (if any) from any of the Trade Marks, and all rights of the Assignor to sue for past, present or future infringements, passing off and damages in relation to any and each of the Trade Marks.

**2. FURTHER ASSURANCE**

The Assignor shall execute all such documents and do all such acts as may be necessary to enable the Assignee to register the assignment contemplated at Clause 1 with the relevant local Trade Mark Registry and to otherwise give effect to the terms of this Deed.

**3. GOVERNING LAW AND JURISDICTION**

- 3.1 The validity, construction and performance of this deed shall be governed by and construed with the laws of England and Wales
- 3.2 Each party agrees to submit to the exclusive jurisdiction of the High Court of England and Wales over any claim, dispute or matter arising under or in connection with this Deed.

**4. COUNTERPARTS**

This Deed may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.
