### ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks is made pursuant to the terms of the Settlement and Trademark Coexistence Agreement dated \_\_\_\_\_, 2020, entered into by and between the Boy Scouts of America ("BSA"), a federally chartered corporation organized under the laws of the United States of America, with its principal place of business at 1325 West Walnut Hill Lane, P.O. Box 152709, Irving, Texas 75015, and D.M. Merchandising, Inc. ("D.M. Merchandising"), a corporation organized under the laws of Illinois, with its principal place of business at 835 N. Church Court, Elmhurst, Illinois 60126.

**WHEREAS**, D.M. Merchandising ("Assignor") has adopted, owns, and is using in its business the mark NIGHT SCOUT (the "NIGHT SCOUT Mark"), which is the subject of U.S. Trademark Application Serial No. 88170555 (the "Subject Application"); and

**WHEREAS**, BSA ("Assignee") is desirous of acquiring the entire right, title and interest in and to the NIGHT SCOUT Mark and the Subject Application, together with the goodwill of the business symbolized thereby.

**NOW, THEREFORE**, in consideration of the mutual covenants of the Parties and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, D.M. Merchandising and BSA agree as follows:

1. Assignor hereby sells, assigns, conveys, and transfers unto Assignee all right, title and interest in and to the NIGHT SCOUT Mark, together with (a) all associated common law and statutory rights, (b) the goodwill of the business symbolized thereby, and (c) all rights and privileges granted and secured thereby, as well as the right to seek any and all remedies available at law or in equity.

2. All of such right, title and interest shall be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment of Trademarks had not been made. Assignor agrees to sign any additional documents needed in order to record this assignment with the United States Patent and Trademark Office.

3. The date of this Assignment is either (a) the date that both parties signed this Assignment, or (b) the last date on which one of the parties signed this Assignment.
