RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this "Release") is effective as of May 12, 2021 by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent (in such capacity, "Agent").

WHEREAS, pursuant to that certain Trademark and Patent Security Agreement, dated as of April 7, 2010, executed VantaCore Partners LP, a Delaware limited partnership ("Grantor") in favor of Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), Grantor granted to Agent a continuing security interest in and continuing lien upon the Trademarks (as such term is defined in the Security Agreement) of Grantor, including, without limitation, the trademarks and licenses listed on Exhibit A hereto, and all products and proceeds of such Trademarks; and

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on June 16, 2010 at Reel/Frame 4225/0909.

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement, Agent hereby (i) releases the continuing security interest and continuing lien upon, and terminates its security interest in, and all other rights, title and interest in and to, the Trademark Collateral (as defined in the Security Agreement), without any recourse, representation or warranty, (ii) terminates the Security Agreement, and (iii) re-assigns to Grantor, any right, title or interest Agent may have in, to or under the Trademark Collateral, together with the goodwill of the business symbolized thereby, and hereby authorizes Grantor or Grantor's authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.
