Assignor confirms that as of the Effective Date Assignor did assign, transfer and convey to Assignee, as its successor, its entire right, title, interest in and to the Marks in Canada and the United States together with the accompanying goodwill and the portion of the business represented and symbolized by the Marks (including, without limitation, the right to renew the associated registrations, the right to apply for trademark registrations based in whole or in part upon the Marks, and any priority right that may arise from the Marks), which business is ongoing and existing, and the right to sue for, and recover for, any past infringements thereof, the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this assignment, transfer and conveyance not been made.

Assignor agrees to further execute any documents reasonably required by Assignee to effect this Assignment or to confirm Assignee's ownership of the Marks.

IN WITNESS WHEREOF, the parties hereto have executed this Assignment effective as of the Effective Date.


