## ASSIGNMENT

This Trademark Assignment is made as of **June 6, 2018** (the "**Effective Date**") by and between **Correvio Canada Corp.** ("**Assignor**"), a corporation under the laws of Canada with its principal place of business at 6<sup>th</sup> Floor, 1441 Creekside Drive, Vancouver, BC V6J 4S7 Canada, and **Correvio International Sàrl** ("**Assignee**"), a corporation under the laws of Switzerland with its principal place of business at Place des Alpes 4, 1201 Geneva, Switzerland (referred to collectively as the "**Parties**").

WHEREAS, Assignor is the sole owner of all rights, title and interest in and to the trademark registrations and applications listed in **SCHEDULE A**, attached hereto, and to the trademarks covered thereby and to the goodwill and reputation of the business connected with and symbolized by these trademarks (the "**Marks**");

WHEREAS, Assignor wishes to assign all right, title and interest in and to the Marks to Assignee, and Assignee wishes to accept such assignment;

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby sells, assigns and transfers unto said Assignee all right, title and interest in and to the Marks listed on **SCHEDULE A**, together with (a) all trademark registrations and applications listed on **SCHEDULE A**; (b) all common law rights related thereto; (c) all goodwill associated therewith; and (d) all benefits, privileges, causes of action, and remedies relating to any of the foregoing, whether before or hereafter accrued (including, without limitation, the exclusive rights to apply for and maintain all such registrations; to sue for all past, present or future infringements or other violations of any rights in the Marks; and to settle and retain proceeds from any such actions).

Assignor shall execute such written instruments and extend such other cooperation as may be reasonably necessary to convey the Marks to Assignee.

This Assignment may be executed in one or more counterparts, and by different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement.

If any provision or provisions of this Assignment are held to be invalid, illegal or unenforceable, in whole or in part, under any law or regulation, by a court of competent

jurisdiction, then such provision or portion of such provision, as appropriate, shall remain in effect only to the extent that it is valid, and the validity, legality and enforceability of the remaining provisions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated thereby.


This Assignment constitutes the entire agreement between the Parties relating to the subject matter hereof and supersedes all prior agreements, understanding and representations concerning such subject matter.

No amendment or modification to any of the terms hereof shall be valid or binding upon the Parties unless made in writing and signed by duly authorized representatives of the Parties.

The Parties have caused this Agreement to be executed by their duly authorized representatives.




