**FIRST:** The name of the Corporation is Mohawk Group, Inc. The Corporation filed its original Certificate of Incorporation with the Secretary of State of the State of Delaware on April 23, 2014, which was most recently restated by a Restated Certificate of Incorporation that was filed with the Secretary of State of the State of Delaware on September 4, 2018 (the "**Restated Certificate**").

**SECOND:** Article I of the Restated Certificate is hereby deleted in its entirety and replaced by the following:

"The name of the Corporation (the "**Corporation**") is Aterian Group, Inc."

**THIRD:** All other provisions of the Restated Certificate shall remain in full force and effect.

**FOURTH:** This Certificate of Amendment has been duly adopted by the Board of Directors of the Corporation acting in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware, as amended (the "**DGCL**"), without the necessity of a meeting or vote of stockholders pursuant to Section 242(b)(1) of the DGCL.
