FIRST LIEN IP SUPPLEMENT

The Grantor grants and pledges to the Collateral Agent (for the benefit of the Secured Parties) a security interest in all of the Grantor’s right, title and interest in and to the Trademark Registrations, Issued Patents and Copyright Registrations and applications therefor and exclusive licenses in respect of any copyright registrations and applications therefor set forth on Schedule A annexed hereto, including all Proceeds and Accessions with respect thereto. All such Intellectual Property shall be deemed to be part of the Intellectual Property Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement.


