**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 14, 2021 (“Release”), is made by **FIDUS INVESTMENT CORPORATION**, a Maryland corporation, as Grantee (“Grantee”) in favor of **AUTO-VEHICLE PARTS LLC**, a Delaware limited liability company, as successor by merger to Marli Manufacturing Co., LLC (“Grantor”), pursuant to that certain Guarantee and Collateral Agreement dated January 3, 2018 (as amended, modified, restated or supplemented from time to time, the “Security Agreement”);

WHEREAS, in connection with the Security Agreement, Grantor executed and delivered a certain Trademark Security Agreement, dated as of June 25, 2018 (the “Trademark Security Agreement”), which is recorded at the United States Patent and Trademark Office (“USPTO”) on July 9, 2018 at Reel 6375 Frame 0365 (“Notice”), whereby Grantor granted to Grantee, a continuing security interest in any and all of Grantor’s right, title, and interest in and to Trademarks, including those Trademarks listed on Schedule I attached hereto;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

SECTION 2. Termination and Release. Grantee, without representation, warranty, or recourse, hereby irrevocably terminates, cancels, discharges, and releases the continuing security interest in Grantor’s right, title, and interest in and to the Trademarks, together with the goodwill of the business symbolized by Grantor’s Trademarks, granted pursuant to the Trademark Security Agreement and the Notice. The Grantee hereby authorizes the Grantor, and any of their designees, to file this Release with the USPTO and/or any other applicable governmental office or agency to evidence the release and termination of the security interest in the Trademarks contemplated hereby. Grantee agrees to execute and deliver to the Grantor all other instruments and other documents as the Grantor may reasonably request to release the security interest in the Trademarks which had been granted under the Notice, in each case, at the sole expense of the Grantor.
