**RELEASE OF TRADEMARK SECURITY INTEREST**

This RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is entered into and made effective as of May 14, 2021 and granted by SILICON VALLEY BANK ("Bank"), , in favor of UNIFIED ENTERPRISES CORP., a Delaware corporation, UNIFIED SOCIAL, INC., a Delaware corporation, SNOWBALL FACTORY INC., a Delaware corporation, and PLM UNIFIED CO., a Delaware corporation (collectively, "Grantor").
