**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Termination") is dated as of May 14, 2021, and made by **ARES CAPITAL CORPORATION**, a Maryland corporation, as Agent ("Grantee") to **DECOPAC, INC.**, a Minnesota corporation and **THE LUCKS COMPANY, LLC**, a Minnesota limited liability company (each, a "Grantor" and, collectively, the "Grantors").

WHEREAS, Grantee and certain Grantors are parties to that certain First Lien Credit Agreement dated as of September 29, 2017 (as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement") and certain First Lien Pledge and Security Agreement dated as of September 29, 2017 (as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, pursuant to that certain (A) First Lien Intellectual Property Security Agreement dated as of September 29, 2017, made by certain of the Grantors in favor of the Grantee, which was (i) recorded in the United States Patent and Trademark Office ("USPTO") on October 4, 2017 at Reel 043777, Frame 0482 and Reel 6172, Frame 0512 and (ii) recorded in the United States Copyright Office on January 4, 2018 at document number V9953D259 (with respect to DecoPac, Inc.) and (B) First Lien Intellectual Property Security Agreement dated as of September 4, 2019, made by certain of the Grantors in favor of the Grantee, which was recorded in the United States Patent and Trademark Office on October 9, 2019 at Reel 050665, Frame 0233 and Reel 6767, Frame 0042 and (ii) submitted to the United States Copyright Office for recordation on October 9, 2019 (with respect to The Lucks Company, LLC), (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, each an "IP Security Agreement" and, collectively, the "IP Security Agreements"), the Grantors granted to the Grantee, among other collateral as set forth therein, a Security Interest in and to certain intellectual property of the Grantors;


WHEREAS, in accordance with the Security Agreement, Grantee now desires to terminate and release its Security Interest in and to the IP Collateral (defined below), including, but not limited to, the intellectual property set forth on the attached Schedule A (collectively, the "IP Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged Grantee hereby terminates the Intellectual Property Security Agreements and hereby terminates, cancels and releases its security interest in and lien on the IP Collateral, and reassigns to each Grantor any right, title or interest it may have in the IP Collateral of such Grantor.
