RELEASE OF SECURITY INTEREST IN TRADEMARKS AND DOMAIN NAMES

This RELEASE OF SECURITY INTEREST IN TRADEMARKS AND DOMAIN NAMES (this “Release”), dated as of May 17, 2021 (the “Effective Date”), is made by Cerberus Business Finance, LLC, a Delaware limited liability company (the “Releasor”), in favor of Gantech Inc. (the “Releasee”).

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated November 14, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), Releasee granted to Releasor for the ratable benefit of the Secured Parties, a security interest in, all of its right, title and interest in and to all of the Collateral (as defined in the Security Agreement);

WHEREAS, pursuant to that certain Security Agreement Supplement – Third Amendment, dated May 28, 2019 (the “Security Agreement Supplement”), Releasee granted to Releasor for the ratable benefit of the Secured Parties a security interest in, and the Collateral includes, without limitation, the trademarks set forth on the Schedule A attached hereto (the “Trademarks”), the common law marks set forth on the Schedule B attached hereto (the “Common Law Marks”), and the domain names set forth on the Schedule C attached hereto (the “Domain Names”);


WHEREAS, Releasee has requested, and Releasor wishes to provide, a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Trademarks, Common Law Marks, and Domain Names.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.
2. Release of Security Interest. Releasor, without representation, warranty or recourse, hereby releases, relinquishes, terminates, cancels and discharges its security interest in the Trademarks, Common Law Marks, and Domain Names.

IN WITNESS WHEREOF, the Releasor has caused this Release of Security Interest in Trademarks and Domain Names to be duly executed as of the date hereof.



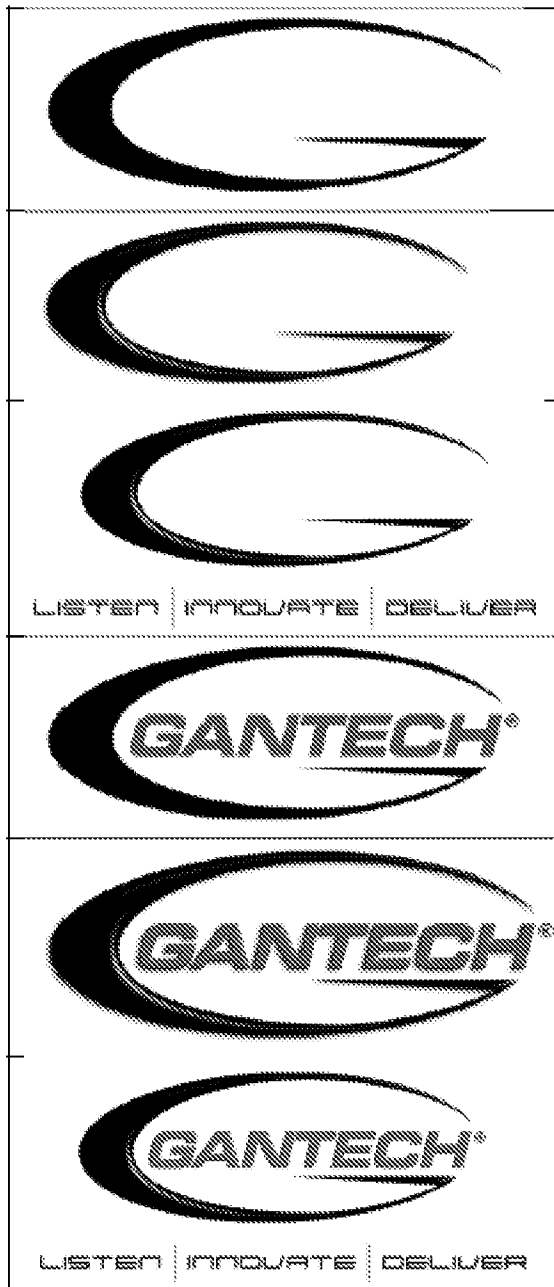

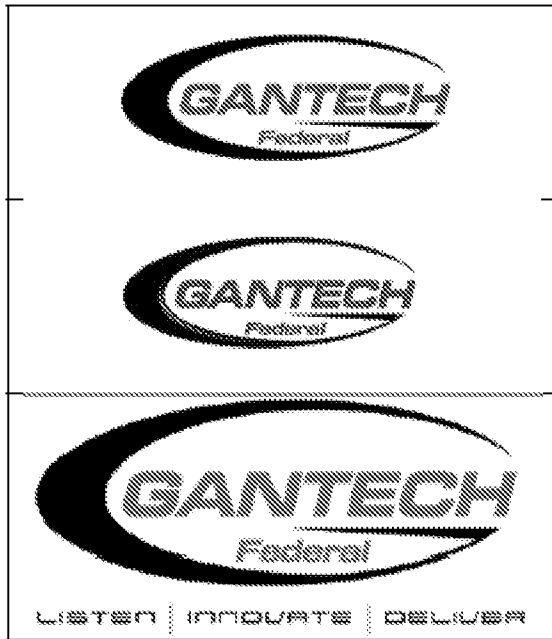
