Trademark Assignment Agreement

Original Manginos Pizzeria Inc., (Assignee) is a Pennsylvania corporation having an address of 4202 Meadowview Blvd New Castle PA 16105.


Mangino's Pizzeria, Inc. is a Florida Corporation having, at one time, an address of 1201 Piper Blvd Unit 17 Naples FL 34110. Charles Mangino is the owner of 100% of Mangino's Pizzeria, Inc. Collectively, Mangino's Pizzeria, Inc. and Charles Mangino are herein identified as Assignors.

Mangino's Pizzeria, Inc. is the record owner of a federally registered trademark bearing registration number 4,405,384 for the mark **MANGINO'S PIZZERIA** for Pizza restaurants featuring dine-in, carry-out and delivery service classified in international class 043. Mangino's Pizzeria, Inc., or Charles Mangino, may also be the owner of common law trademark rights in other related mark(s) used for Pizza restaurants featuring dine-in, carry-out and delivery service, or in the mark **MANGINO'S PIZZERIA** used in a manner not encompassed by the registration. Collectively all of these trademarks are referenced as the MARKS.

The Parties enter into this this Trademark Assignment Agreement which is to be effective as of December 31, 2019 (the "Effective Date"), between Assignors and Assignee.

In exchange for one dollar and good and valuable consideration, the receipt of which is hereby acknowledged, the Assignors hereby irrevocably conveys, transfers, and assigns to the Assignee all of Assignor's respective right, title, and interest of whatever kind in the MARKS, together with the goodwill of the business relating to the goods or services on which the MARKS are used and/or for which they may be registered; and all income, royalties, and damages previously accrued and uncollected, now due and hereafter due or payable to Assignor with respect to the MARKS, including without limitation, damages, and payments for past or future infringements and misappropriations of the MARKS; and all rights, but not the obligation, to sue for past, present and future infringement or misappropriations of the MARKS.

Assignors further covenant that it will take all actions that may be necessary for securing, completing, or vesting in the Co-Owners full right, title, and interest in the Marks
