RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS

WITNESSETH:

WHEREAS, Royal Oak Enterprises, LLC (the “Owner”), a Delaware corporation with its principal place of business at 1 Royal Oak Avenue, Roswell, Georgia 30076, is the current owner of record of the trademarks listed on the attached Exhibit A, issued in the United States Patent and Trademark Office (the “Trademarks”), as recorded at the United States Patent and Trademark Office on May 23, 2017, at Reel 6067, Frame 0015; and

WHEREAS, Bank of America, N.A. (the “Secured Party”), was a party to one or more security agreements with Jarden Corporation, f/k/a Alltrista Corporation (the “Debtor”), which granted to the Secured Party a security interest in the Trademarks, a true and correct copy of which was recorded by the United States Patent and Trademark Office on December 3, 2003, at Reel 2870, Frame 0596;

WHEREAS, Security Pacific Business Credit, Inc. was previously a party to one or more security agreements with Diamond Match Company, a prior debtor, which granted to Security Pacific Business Credit, Inc. a security interest in three of the same Trademarks, a true and correct copy of which was recorded by the United States Patent and Trademark Office on May 9, 1983, at Reel 0440, Frame 0961;

WHEREAS, the Secured Party merged with the parent corporation of Security Pacific Business Credit, Inc., Security Pacific Corp., on April 22, 1992, causing the transfer of Security Pacific Corp’s assets including any remaining security interest in the Trademarks; and

WHEREAS, the Secured Party has released and discharged its security interest in the Trademarks, and those interests have been assumed by the Owner, but the Secured Party’s release has not been recorded at the United States Patent and Trademark Office;

NOW, THEREFORE, the Secured Party hereby:

1. releases and discharges any and all liens, security interests, right, title, and interest of Secured Party in the Trademarks identified in Schedule A, without recourse or representation or warranty, express or implied; and
2. authorizes and requests the Commissioner for Trademarks of the United States to note and record the existence of the release hereby given.
