RELEASE OF SECURITY INTEREST IN TRADEMARKS

KNOW ALL MEN BY THESE PRESENTS, that ISRAEL DISCOUNT BANK OF NEW YORK ("**Secured Party**"), DOES HEREBY CERTIFY that the continuing security interest, general lien and collateral assignment it holds, pursuant to the Trademark Security Agreement, dated as of March 2, 2020, notice of which was recorded in the United States Patent and Trademark Office ("**USPTO**") on March 16, 2021 at Reel 7233, Frame 0915 (as heretofore amended, modified or supplemented, the "**Security Agreement**"; capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement), by and among MIGEAR INTERNATIONAL LLC, a New York limited liability company ("**Specified Grantor**"), certain of Specified Grantor's affiliates and Secured Party, in the Trademarks identified on Schedule A annexed hereto and made part hereof (the "**Released Trademarks**"), and any and all other Trademark Collateral relating solely to the Released Trademarks (together with the Released Trademarks, collectively, the "**Released Trademark Collateral**"), including the goodwill of the business symbolized thereby, are hereby released and all right, title and interest in the Released Trademark Collateral previously assigned to Secured Party under the Security Agreement, including the continuing security interest, general lien and special power of attorney, is hereby terminated and reassigned to Specified Grantor, without recourse, representation or warranty of any kind, nature or description.

Secured Party hereby authorizes Specified Grantor or Specified Grantor's authorized representative to record or file this Release of Security Interest in Trademarks ("**Release**") with the Commissioner for Trademarks and any other government officials to record and register this Release. Secured Party further agrees to execute and deliver to Specified Grantor any and all further documents and instruments, and to do all further acts which Specified Grantor (or its agents or designees) reasonably requests (at Specified Grantor's sole cost and expense) to confirm this Release and Specified Grantor's right, title and interest in and to the Released Trademark Collateral.

Nothing contained in this Release shall constitute or be construed as a termination, release, retransfer or reassignment by Secured Party of any security interest or any other right, title or interest Secured Party may have in any Trademark Collateral (other than the Released Trademark Collateral as set forth herein) or any other collateral described in the Security Agreement or otherwise, all of which shall continue in full force and effect.

This Release shall be governed by and construed in accordance with the laws of the State of New York as applied to agreements among parties resident therein.
