**TERMINATION OF TRADEMARK SECURITY AGREEMENT**

This **TERMINATION OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), dated as of May 19, 2021, is made by **CHURCHILL AGENCY SERVICES LLC**, a Delaware limited liability company, in its capacity as Administrative Agent for itself and the other Lender Parties, the "Agent"), in favor of **good2grow LLC** ("Grantor"). Unless otherwise defined herein, capitalized terms used in this Termination shall have the meanings assigned to such terms in the Trademark Security Agreement (as defined below).

**WHEREAS**, the Grantor and the Agent entered into that certain Trademark Security Agreement, dated as of November 16, 2018 (the "Trademark Grant");

**WHEREAS**, pursuant to (i) that certain Pledge and Security Agreement, dated as of November 16, 2018 (as amended, modified, extended, restated, renewed, replaced, or supplemented from time to time, the "Security Agreement"), by and among the Grantor party thereto from time to time and the Agent and (ii) the Trademark Grant, the Grantor pledged and granted to the Agent a security interest in and to and continuing lien on all of the Grantor's right, title and interest in, to and under the Trademarks, including those Trademarks and Trademark applications listed on Exhibit A attached hereto; and

**WHEREAS**, the Agent has agreed to terminate, release and discharge its security interest in and to and lien on all right, title and interest of the Grantor in, to and under the Trademarks and reassign any and all such right title and interest to the Grantor.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby terminates, cancels, releases and discharges all of its mortgages, liens, and security interests in, to and on all of the Grantor's right, title and interest in, to and under the Trademarks and hereby reassigns, without any representation, warranty, or recourse whatsoever, any and all such right, title and interest to the Grantor.

2. This Termination may be filed with the United States Patent and Trademark Office to evidence Agent's release of the security interest against such Trademarks.

3. THIS TERMINATION SHALL BE GOVERNED BY AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
