Pursuant to Title 8, Sections 252 and 264 of the Delaware General Corporation Law (the "DGCL"), the undersigned executed the following Certificate of Merger:

**FIRST:** The name of the company surviving the merger is UL Verification Services Inc., a Delaware corporation (the "Surviving Company"), and the names of the companies being merged into the Surviving Company are UL Registrar LLC, a Connecticut limited liability company ("Registrar"), Healthy Buildings International, Inc., a New Jersey corporation ("HBI") and Healthy Buildings Solutions, LLC, a Virginia limited liability company ("HBS"), and together with Registrar and HBI, the "Terminating Companies")

**SECOND:** An Agreement and Plan of Merger, dated as of December 27, 2019 (the "Agreement of Merger"), by and among Registrar, HBI, HBS and the Surviving Company has been approved, adopted, certified, executed and acknowledged by each of the constituent companies in accordance with the DGCL, the New Jersey Business Corporation Act, the Virginia Limited Liability Company Act or the Connecticut Uniform Limited Liability Company Act, as applicable.

**THIRD:** Prior to the effective date of this Certificate of Merger, the Surviving Company owns one hundred percent of the membership interests of Registrar and one hundred percent of the issued and outstanding stock of HBI (6,825.80 common shares, no par value). HBI owns one hundred percent of the membership interests of HBS.

**FOURTH:** The merger shall become effective as of 12:01 AM on January 1, 2020.

**FIFTH:** The Agreement of Merger is on file at the place of business of the Surviving Company at c/o UL LLC, 333 Pfingsten Road, Northbrook, IL 60052

**SIXTH:** A copy of the Agreement of Merger will be furnished by the Surviving Company, on request and without cost, to any stockholder of any constituent corporation or any member of any constituent limited liability company.

**SEVENTH:** The certificate of incorporation of the Surviving Company shall continue in full force and effect as its Certificate of Incorporation following the Merger.
