## **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (“Release”) is made and effective as of May 21, 2021 (“Effective Date”) and is granted by **Cantor Fitzgerald Securities**, as trustee and collateral agent for the Secured Parties (in such capacities, together with successors and assigns in such capacities, the “Agent”), in favor of **Colt’s Manufacturing Company LLC**, a Delaware limited liability company, having an office at 545 New Park Avenue West Hartford, CT 06110; **New Colt Holding Corp.**, a corporation organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 545 New Park Avenue, West Hartford, Connecticut 06110; **Colt’s Manufacturing IP Holding Company LLC**, a limited liability company organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 545 New Park Avenue, West Hartford, Connecticut 06110; and **Colt Canada IP Holding Partnership**, a partnership formed under the laws of the Province of Nova Scotia, with offices and a place of business located at 1036 Wilson Avenue, Kitchener, Ontario NC2 1J3, Canada (the “Grantors”).

**WHEREAS**, the Grantors executed and delivered to the Agent that certain Trademark Security Agreement, dated as of January 13, 2016 by and among Grantors and Agent (including all annexes, exhibits or schedules thereto, and as from time to time amended, restated, supplemented or otherwise modified, the “Trademark Security Agreement”.

**WHEREAS**, pursuant to the Trademark Security Agreement, Agent, for the benefit of each Secured Party, is the holder of a continuing security interest in all of Grantors’ right, title and interest in, to and under all Trademark Collateral, including, without limitation, the Trademarks listed on Schedule I pursuant to the Trademark Security Agreement (as from time to time amended, restated, supplemented or otherwise modified).

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005709, Frame 0260 on January 14, 2016.

**WHEREAS**, Grantors have requested that the Agent enter into this Release in order to effectuate, evidence and record the termination and release to the applicable Grantor having granted a security interest in such collateral of any and all right, title and interest the Agent and the Secured Parties may have in the Trademark Collateral pursuant to the Trademark Security Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantors and Agent agree as follows:

1. All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Agent, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates the Trademark Security Agreement and forever unconditionally, expressly and irrevocably releases, terminates and discharges all security

interests that Agent and the Secured Parties have pursuant to the Trademark Security Agreement in, to and under the Trademark Collateral, including, without limitation, the Trademarks listed in **Schedule 1** hereto all of the goodwill of the business connected with the use thereof, and symbolized thereby and all products and proceeds (as that term is defined in the Uniform Commercial Code of New York), of the foregoing, all without recourse, warranty or representation of any kind other than in connection with Agent's right to release all such security interests on behalf of itself and the Secured Parties, their successors, legal representatives and assigns.

3. Agent hereby authorizes and requests (a) the Commissioner of Patents and Trademarks to record this Release in the United States Patent and Trademark Office with regard to the Trademark Security Agreement and the Trademark Collateral; (b) the Registrar of Trademarks to record this Release in the Canadian Intellectual Property Office with regard to the Trademark Security Agreement and the Trademark Collateral and (c) any other state, federal and/or foreign government agency to record this Release with regard to the Trademark Security Agreement and the Trademark Collateral.

4. Agent agrees, at the Grantors' expense, to take all further actions, and provide to the Grantors and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantors and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

5. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).

6. This Release may be executed in multiple counterparts, each of which shall be deemed an original, with the same effect as if the signatures thereto and hereto were upon the same instrument.
